Bret Banks shared background information and answered questions from the Board. Upon Motion by **CHELETTE**, Seconded by **MANN**, and unanimously approved, the Board: **Adopted** a resolution amending the Conflict of Interest Code for Antelope Valley Air Quality Management District (AVAQMD) and directed staff action.

Agenda Item #7 - Annual Financial Audit for Fiscal Year 2016-17. The annual audit for Fiscal Year 2016-17 is complete and presented for review and to receive and file. Fedak & Brown LLP of Cypress performed the audit services for the District. This was the first year to perform the audit of a three year engagement.

Laquita Cole introduced Christopher J. Brown, CPA, CGMA of Fedak & Brown LLP who presented the annual audit information and answered questions from the Board. Chair **CRIST** requested in the future that a board member from each jurisdiction be contacted prior to the audit review and presentation. After discussion and upon Motion by **MANN**, Seconded by **HAWKINS**, and unanimously approved, the Board: **Received and filed** the annual audit for Fiscal Year 2016-17.

Agenda Item #8 - Community Air Protection Authorization. 1) Approve the FY 17-18 Grant Agreement for submission to the California Air Resources Board (CARB) for the implementation for expenses necessary for the implementation of Assembly Bill 617 (C. Bret Banks presented background information and answered questions from the Board. Board discussion directed staff to write the 36th Assembly District Assemblyman Tom Lackey and Senator Scott Wilk requesting additional funding for the Antelope Valley communities. The Board recommended that a partnership be created among the Association of Rural Town Councils, City of Lancaster, City of Palmdale, Los Angeles County Health Department and the Antelope Valley Air Quality Management District (AVAQMD) and directed AVAQMD staff to be the lead agency in this partnership to develop and submit a proposed AB 617 project to the California Air Resources Board by April 30, 2018. After discussion and upon Motion by MANN, Seconded by BISHOP, and unanimously approved, the Board: 1) Approved the FY 17-18 Grant Agreement for submission to the California Air Resources Board (CARB) for the implementation for expenses necessary for the implementation of Assembly Bill 617 (C. Garcia, Chapter 136, Statutes of 2017); 2) Authorized the Executive Director/APCO and staff to execute the agreement, approved as to legal form.

RECOMMENDATION: 1) Rescind award amount not to exceed \$100,000 in Carl Moyer Program and Mobile Source Emission Reductions Program (AB 2766) funds to Kyle & Kyle Ranches for the replacement of an older heavy-duty on-road diesel Hay Squeeze with newer, cleaner diesel engine technology and authorize award to be fully funded with AB 2766 funds; and 2) Authorize the Executive Director/APCO and staff to negotiate target time frames and technical project details and execute an agreement, approved as to legal form by the Office of District Counsel.

SUMMARY: This items rescinds a previous award consisting of Carl Moyer Program funds not to exceed \$31,984 leveraged with Mobile Source Emission Reductions Program (AB 2766) funds not to exceed \$68,016, and authorizes the grant project to be fully funded for an amount not to exceed \$100,000 of AB 2766 funds to Kyle & Kyle Ranches to replace a model year 1996 diesel Hay Squeeze with a model year 2017 Hay Squeeze with engine certified to the 0.20 g/bhp-hr NOx standard.

BACKGROUND: On February 20, 2018, the Governing Board awarded an amount not to exceed \$100,000 in Carl Moyer Program and Mobile Source Emission Reductions Program (AB 2766) funds to Kyle & Kyle Ranches for the replacement of an older heavy-duty on-road diesel Hay Squeeze with newer, cleaner diesel engine technology. After staff review of pending projects and available funds, staff recommended the Kyle & Kyle Ranches replacement project to be fully funded with Mobile Source Emission Reductions Program (AB 2766) funds in order to make available sufficient Carl Moyer Program funds needed for pending and upcoming projects. Therefore, \$31,984 will be returned to the Carl Moyer Program and deducted from AB 2766 for an amount not to exceed \$100,000.

Budget Foundation

SUMMARY: This item awards an amount not to exceed \$185,943 in Carl Moyer Program funds to McWhirter Steel for the replacement of two (2) diesel-powered heavy-duty forklifts used in their daily handling of steel materials. The new forklifts are certified to the current off-road emissions standards.

BACKGROUND: AVAQMD received an application from McWhirter Steel requesting grant funding towards retirement and replacement of older diesel-powered heavy-duty forklifts. McWhirter Steel proposes voluntary participation in the Carl Moyer Equipment Replacement Program to reduce emissions by retiring one (1) 1995 CAT DP70 and (1) 2005 CAT DP90 forklifts to receive grant funding to off-set the costs to purchase two (2) new diesel-powered heavy-duty forklifts certified to the current off-road emissions standards. McWhirter Steel is an Antelope Valley business since 1992 that started under the name D&D Welding. McWhirter Steel is in compliance with the off-road regulation and is taking the opportunity to receive grant funding to incorporate cleaner equipment into their fleet. The proposed project is estimated to reduce 2 tons of early emissions reductions for a proposed 5-year project term. Early fleet turnover provides emission reductions that help the Valley towards attainment of the national ambient air quality standards.
